

**AMENDMENT NUMBER 1 TO THE BID DOCUMENTS**  
**Amendment Date: January 2, 2023**

**A. This Amendment shall be considered part of the bid documents for the above-mentioned project as though it had been issued at the same time and shall be incorporated integrally therewith. Where provisions of the following supplementary data differ from those of the original bid documents, this Amendment shall govern and take precedence. BIDDERS MUST SIGN THE AMENDMENT AND SUBMIT IT WITH THEIR BIDS.**

**B. Bidders are hereby notified that they shall make any necessary adjustments in their estimates as a result of this Amendment. It will be construed that each bidder's proposal is submitted with full knowledge of all modifications and supplemental data specified herein.**

Except as described below, the original bid document remains unchanged. The bid documents are modified and/or clarified, as follows:

**B. SITE CONDITIONS**

\*The following is in addition to the original specification.

- The current floor system is a 2x3 sleeper installed 12" on center with 33/32 x 2 ½ maple. The thickness of the existing floor is between 2-3/4" and 2-7/8".

**E. WOOD FLOORING**

\*The following serves to replace the specification of the Horner Sports Flooring with a general specification.

- Manufacturer shall be an established firm experienced in the products specified in this section and have been in business a minimum of twenty-five (25) years.
- Manufacturer shall be a member in good standing of the Maple Flooring Manufacturers Association (MFMA).
- Materials other than those specified must be approved prior to submission of a response.
- The flooring contractor shall be a certified installer of the manufacturer's products.
- The flooring contractor shall install the floor per the manufacturer's guidelines and recommendations.
- SCS has selected a floating floor system as its' preferred product. The key features are as follows:
  - Subfloor
    - 6 mil or better polyethylene vapor barrier over concrete slab
    - Rolled foam or cushioned pads, ¼" or more thick
    - 2 layers of 15/32" x 4' x 8' rated sheathing, exposure 1, plywood
  - Flooring
    - MFMA Northern Hard Maple, grade marked and stamped
    - 25/32" x 2-1/4"
    - 2<sup>nd</sup> or better grade

- Fasteners
  - Subfloor fastened with 1" coated staples
  - Hardwood flooring fastened with 2", 15-gauge coated staples
- Sanding will be completed per MFMA and floor coating system guidelines.
- SCS has selected Hillyard as its' preferred floor coating system.
  - Hillyard Star Seal Base Coat x 3
  - Hillyard Icon Gym Finish x 2
- Game lines, logos, floor staining and other artistic features to be determined after award. The cost will be included in the Discretionary allowance.
- Install new vent cove base.
- SCS requests optional pricing for the installation of standard volleyball court layout floor sockets with locking brass floor plate. Include a price for a standard court configuration and a side-by-side configuration.
