

**AMENDMENT NUMBER 1 TO THE BID DOCUMENTS**

**Amendment Date: May 6, 2024**

**A. This Amendment shall be considered part of the bid documents for the above-mentioned project as though it had been issued at the same time and shall be incorporated integrally therewith. Where provisions of the following supplementary data differ from those of the original bid documents, this Amendment shall govern and take precedence. Except as described below, the original bid document remains unchanged. The bid documents are modified and/or clarified, as follows:

**BIDDER MUST ACKNOWLEDGE THIS AMENDMENT BY SIGNING BELOW AND ATTACHING THE SIGNED AMENDMENT TO THE BID FORM:**

The bid specification includes the option to price 16mm and 13mm displays. SCS shall award the bid based on the display that best fits the needs of SCS and aligns with budgetary constraints. The Contractor is not required to submit Optional Pricing.

**LED Module** (minimum specifications)

\*It is recommended that Contractors include product literature with their bid proposal.

- **Matrix Size:**
  - Approximate Dimensions: 3ft. 2 in. tall x 8ft. 8in. wide
    - Actual size may vary but must not exceed the dimensions listed above.
  - Minimum of 20mm
    - Optional pricing for 16mm and 13mm displays.
  - Must display a minimum of 8 lines.
  
- **Full Color**
  - Pixel Spacing: The Contractor must quote a minimum of 20mm or equivalent displays. The Contractor may include optional pricing for 16mm and 13mm displays.
  - Color Capability: Must have the ability to display a total color palette.
